The Contracting Supplier shall adhere strictly to the terms and conditions of the Terms of Reference (TOR).

The Contracting Supplier shall be paid the contract amount in full within **thirty (30) calendar days** upon delivery and inspection & acceptance by NSC Inspection Committee subject to deduction of applicable taxes.

1. The quotation must be typewritten in the company's letterhead.
2. PhilGEPS Registration Number, Mayor's or Business Permit, Income Tax or Business Tax Return and Notarized Omnibus Sworn Statement shall be attached upon submission of the Quotation.
3. The quotation shall be considered as fixed prices and not subject to price escalation during the contract implementation.
4. Payment shall be made through Advice to Debit Account upon receipt of the supplier's statement of account, subject to deduction of applicable taxes.
